Memorandum of Understanding

This Memorandum of Understanding (hereby referred to as 'MoU') is entered into on the 1st day of August, 2025 by and between

ST. JOSEPH'S COLLEGE, P.O. North Point, Dist. Darjeeling, West Bengal- 734 104 of ST. JOSEPH'S COLLEGE (hereby referred to as 'SJC'), which expression unless excluded by or repugnant to the subject of context shall include its successors-in-office, administrators or assigns

And

VIGYAN BHARATI UTTAR BANGA (hereby referred to as 'VIBHAU'), Registered at 38/Ramkrishna Sarani, Shivmandir, Siliguri, Dist. Darjeeling, West Bengal- 734 011 presented by Dr Kanak Kanti Baishya, Secretary, Vigyan Bharati Uttarbanga.

Whereas, the first party is a Higher Educational Institution named ST. JOSEPH'S COLLEGE a government aided institute affiliated to University of North Bengal.

VIBHAU aims to impart market aligned skill and career development internship training program for the students of SJC in collaboration at the premises of SJC. With this collaboration participants

will get the opportunity to enhance their skill through digital and theoretical classes. All successful trained students will get a certificate. Internship on the following module will be imparted

1. Certificate of Drone Assembling and its Applications (DAA), 60 hours.

AREAS OF COOPERATIONS:

Whereas SJC and VIBHAU recognize that the academic collaboration would be of mutual benefit and would provide strengths in research and education and their mutual interest in engaging themselves in academic cooperation. Following the purpose of the agreement, two parties shall engage in activities as stated below:

1. Internship/apprentice programs for students of SJC.
2. Soft skill and career development internship training program.
3. Extension activities with focus on education.
4. Collaboration in the field of education.
5. Sharing of Infrastructure for the purpose of academic cause only.

Benefit and Guidelines for students

Internship program

- Training to be conducted in mixed mode i.e., online as well as offline mode.
- Students have to complete the final assessment to the certificate.
- Minimum 80% of the total classes conducted (online & offline).

Security Deposit and Refund Policy

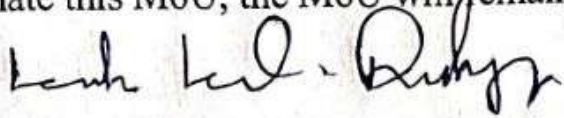
- A nominal charge of Rs. 600/- (Rupees six hundred) only will be charged from each student and after assessment and certification it will be refunded within a reasonable time.
- If a student does not attend the minimum number of classes for certification in first 30 calendar days after admission, student will be notified of dropout and security money is not be refundable for dropout students.

Financial Clause

VIBHAU will not provide any charge against students of SJC for internship program.

Termination of MoU

Either party may terminate this MoU by giving 30 days' prior notice. Unless otherwise terminate this MoU, the MoU will remain effective till March 2026.
